The Program also includes four moderated panels discussing a variety of topics. A total of thirteen presentations from a well-qualified group of industry executives and thought leaders, including representatives from: Bank of America Merrill Lynch, Duke Energy, CF Industries, ConocoPhillips, Dominion Energy/Atlantic Coast Pipeline, Kinder Morgan, Williams, Direct Energy, Prometheus Energy, D&S Americas/Chart Inc., NiChe LNG, EMEX Utility Group, Southern Company, ArcelorMittal, Tennessee Valley Authority, and Municipal Gas Authority of Georgia.

This Forum focuses on the Southeast U.S. market, while five other Forums throughout the year address other key regions across the continent.

Participants at the Forum include market leaders, decision makers and subject matter experts. Industry segments represented include utilities, industrial gas consumers, producers, pipelines, marketers, regulators and analysts. 
